INTRODUCTION

This report is intended primarily for students enrolled in the University of Pittsburgh's graduate program in Latin American history. Its goal is to provide those students with an introduction to the primary materials that they will be using in research seminars and, in many cases, to satisfy the research requirement for the MA degree². However, it is our hope that this

report might also be useful to students and faculty in other departments, and to anyone interested in Hillman Library's Eduardo Lozano Latin American Collection³.

This report does not claim to be an authoritative or exhaustive listing of Hillman's primary research materials. Limitations of time and energy precluded our conducting a comprehensive survey of the library's holdings. Even had we been able to do so, the continuing program of acquisitions and purchases supervised by Eduardo Lozano would require such a list to be updated constantly. We therefore decided that it would be most useful to introduce students to some of the areas of strength in the collection, and then suggest procedures for using Hillman's on-line catalogues and data bases to search for additional such material.

The report begins with an introductory section on general reference works. It then examines the three sections of Hillman Library where primary materials on Latin America are most likely to be found: the Microforms and Government Documents sections (ground floor), the General Collection (third and fourth floors) and the materials on storage on Thomas Boulevard. These materials can be requested on line and will be delivered at the requested location. It concludes with two appendices: one listing examples of multi-volume collections of primary documents, and another discussing the use of the Internet for historical research on the region.⁴

REFERENCE

Reference assistance is available both at the Reference Desk and from Eduardo Lozano. As the creator and long-time bibliographer of the collection, Mr. Lozano knows its every nook and cranny, and is a genius at finding items that have been lost, incorrectly catalogued, or (occasionally) not catalogued at all. His detailed knowledge of the library, of Latin America, and of seemingly everything that has been written on the region, makes him a truly invaluable source of specialized information. He can usually be found at his office, 171 Hillman, and is always willing to help those wishing to make use of the collection.

Two of the most important reference sources on Latin America are now available both in print and electronically. These are the **Handbook of Latin American Studies** (HLAS, 1935--) and the **Hispanic American Periodical Index** (HAPI, 1977--), both published annually. These multi-volume collections are located in Latin American Reading Room (1st Floor). Each volume is indexed by author, subject, and country. HLAS includes selected books and articles from specialized journals; HAPI includes only journal articles. Both publications can also now be searched electronically through the Internet:

Other print bibliographies available in the Reference Section include:

Anuarios bibliográficos. Country-specific annual publications, dating in some cases back to the 1800s. Hillman has Anuarios from Brazil, Bolivia, Colombia, Cuba, the Dominican Republic, Ecuador, Guatemala, Mexico, Nicaragua, Peru, and Venezuela.

Bibliografía cubana. Havana, 1916-1927. 11 volumes, covering from the 1600s through the early 1900s. Between microforms and paper issues the library has: 1900-1936; 1959-1975; 1977-1989; 1992-1993; Siglos XVIII-XX

Since most university catalogues are now available electronically (see Appendix 2), these printed catalogues have been discontinued. They remain useful, however, for searching for older holdings and publications, not all of which have been entered into on-line catalogues. The printed catalogues may be found on the compact shelves on the north wall of the ground floor.

There are numerous electronic bibliographical databases licensed to the University of Pittsburgh, most of which may be accessed either through the networked computers located on the ground floor of Hillman or through any other computer operating through a university server; simply follow the links from the Hillman Library home page (<http://www.library.pitt.edu>), either through "Databases A-Z or Databases and Subject." MICROFORMS

The Microforms section of Hillman, on the ground floor, contains the library's holdings of microcards, microfiche, and microfilm. In terms of primary documentation, this is the richest section of the Lozano Collection, and may well constitute the largest collection of Latin America-related microforms in the United States. There are three ways to search for Latin American holdings in this section. The first is through the library's on-line catalogue, PittCat. The second is in the [Latin American selected Microforms Collections](#) found under [Research Guides](#) in the Eduardo Lozano Latin American Collection's web page at:

Finally, some of the documentary series within the collection have indexes prepared by the publisher or archive from which they were purchased. For most of the collection, however, these are not available, so that students will have to rely primarily on PittCat and the Lozano's Collection's web page.

Given the enormous size of the collection, we will only provide a general description of some of its areas of concentration, with some specific examples to illustrate its holdings. We should also note that, in addition to its primary documents, the Microforms section contains numerous secondary titles on Latin American history, social sciences, and humanities.

MICROFILMS

US government records.

Much of the primary material on microfilm consists of archival records generated by agencies of the US government. Indices or catalogues are available for most of these collections, and may be found by asking the Microforms librarian. Occasionally, however, these indices fail to cover the entire collection, and thus underestimate their size and coverage (both of countries and time periods). The interested student is therefore urged to consult the collections directly.

(1) U.S. Department of State. Consular Dispatches. (Several hundred rolls; HCI-80) Most of the documents in this collection are from the second half of the century (through 1906), though there is material from the first half as well. Some of the rolls contain indices, and there is a general index to the collection. (The general index appears to be incomplete. It does not include, for example, reports from the following cities:

OTHER DOCUMENTS

Princeton University Latin American Pamphlet Collection (several hundred rolls; F238-50, HN 11-13, KGI, KHP1, KHWI). Pamphlets and other publications, organized by country and within each country by topical area. The latter include: human and civil rights, women and gender issues, culture, politics, Church and religion, socioeconomic conditions, etc. For further information, see the Guide to the Princeton University Latin American Microfilm Collection (1993) Z1601 G8955.

Latin American anarchist and labour periodicals, 1880-1940 (microfilm HD 57 103 Reels) Reproduces the IISH collection of periodicals from the formative period of Latin American labour movements and anarchist groups (1890-1920). The Austrian anarchist, historian and collector Filmed from the holdings of the International Institute of Social History, Amsterdam, Holland. Max Nettlau (1865-1944), amassed the most significant segments of the collection. Accompanied by a printed guide, entitled: Guide to the microform collection Latin American anarchist and labour periodicals, c. 1880-1940.

Latin American Documents (1,180 rolls, FA3). An immense collection of books, pamphlets, and other published sources. It has no apparent scheme of organization; each roll contains a mixture of primary and secondary sources dealing with various countries and topics. There is a general index to the collection (an approximately 300-page blue folder), which indicates the contents of each roll of film.

International Census Publications. Series II. Pre-1945 (H414). A collection of census reports which includes abundant material from Latin America. The specific countries and dates for

which census data are available may be found in the collection's index, International Census Publications (R Z7164 D3R47 1984).

Latin American Travel. (GAI Ser 1 Pt 1). Books and pamphlets from the Latin American discovery and exploration to the 20th century. 1755 titles in 257 microfilm reels. Travelers' accounts from the nineteenth and early twentieth centuries. The emphasis is on Mexico, but many accounts deal with other countries as well. The index to the collection is a 100-page green folder which indicates the travelers' names, and the years and countries of their travels. The collection was published under four different titles:

- Travel Literature for 1966. Serie I: The Americas. Part I: Mexico;
- Mexican Travel Literature on microfilm;
- Travel Literature: The Americas;
- Latin American Travel.

Hispanic Culture Series. A collection of 2,389 titles of Spanish, Portuguese, and Latin American books from the 15th to the 17th centuries. Based upon Jose Simon Diaz "Bibliografía de la Literatura Hispánica", Henry Thomas "Short-title catalogues of Spanish, Spanish-American and Portuguese books printed before 1601, in the British Museum", and Claire Louise Penney "List of Books printed before 1601 in the Library of the Hispanic Society of America". 2,389 titles in 595 reels of microfilm.

Latin American History and Culture. An Archival Record, The Yale University Collection of Latin American Manuscripts. Considered to be the premier Latin American archive in the U.S. and one of the best in the world, this collection contains an extremely rich and varied assortment of original and copied manuscripts from Mexico, Peru and other areas of Latin America. The materials relate primarily to the civil and religious history of Mexico and Peru.

Latin American Independence. Nineteenth Century Political and Official Pamphlets from the British Library, London. Collection of 534 Latin American pamphlets and broadsides the majority of which were printed in the 19th century. Of these, many date from the early years of independence and were published in the River Plate Region. The greater part of the collection was formed by the Argentinean writer Luis López Domínguez (1810-98). He was a political journalist, historian, politician and ambassador. Other pamphlets in the collection belonged to the Argentinean Lorenzo López, also a deputy for Buenos Aires. The majority of the documents concern politics or are official publications. Famous names recur throughout: Bartolomé Mitre, Manuel Dorrego, Juan Manuel de Rosas, Esteban Echevarría, Domingo Sarmiento.

Documentos oficiales de la Organizacion de los Estados Americanos.

A collection of official documents produced in connection with OAS meetings held since 1966. There is a nine-volume index to this collection, which provides call numbers to specific documents. The collection is filed in the "0" drawer, as is a smaller collection of documents described in the catálogo de informes y documentos técnicos de la OEA.

Annual Reports of the World's Central Banks. Numbers 98-129 of that collection are reports of Latin American and Caribbean central banks since 1980. The collection is described in a one-page "Guide to the Annual Reports of the World's Central Banks." Browsing through the microfiche drawers one finds additional annual reports from central banks, and some statistical material.

For instance, there are data for Argentina for 1915, 1944 to 1950, 1957; Bolivia 1917, 1919, 1973; Brazil, 1936; Chile 1882-83, 1953-58, 1940-64, and so on. The collection does not appear to have an index.

MICROCARDS

The collections in this section includes Latin American Documents in Microcard, found under 'L' in the Microcard drawers. This is a large collection which apparently reproduces official and quasi-official documents listed in the 'Recent Books' section of the Inter-American Review of Bibliography. There is no index or catalogue to this collection, so its contents can only be verified by going through the cards themselves. At this point it is difficult to assess to what extent they contain primary materials.

MATERIALS OF COLLABORATIVE PROJECTS

Latin American Microform Project (LAMP) <http://www.crl.edu/areastudies/LAMP/index.htm>

Additional research material in microform is available from the Latin American Microform Project (LAMP), a collaborative project involving thirty American universities, including the University of Pittsburgh. Headquartered at the Center for Research Libraries in Chicago, LAMP maintains a large collection of nineteenth- and twentieth-century sources from every Latin American country. As the library is a member of the Center for Research Libraries, this material is readily available to member libraries through interlibrary loan.

A regularly updated catalogue of LAMP's holdings is in the Reference Section (Latin American and Caribbean Research Material (Z1610 C418.)) The collection is especially strong in periodical literature (magazines, newspapers, journals), official publications (reports of governmental agencies, presidential messages, statistics), and Church publications. There is also a very large collection of newspapers, magazines, and other periodicals from Haiti (the list occupies 31 pages of the catalogue).

GOVERNMENT PUBLICATIONS

This section of the library, which consists of documents generated by the government of the United States, contains considerable information on Latin America. However, most of it forms part of series or collections not focused on Latin America per se. To further complicate matters, much of the Government Documents collection does not appear in the on-line or card catalogues. As a result, locating Latin America-related material in this section of Hillman can

be difficult. Students are encouraged to consult the Government Publications librarians for assistance.

The basic reference source for this section of the library is the Monthly Catalog of U.S. Government Publications, published continuously since 1895. Its annual volumes are indexed by author, title, and subject, and can thus be used to locate documents--e.g., Departmental publications and reports, Congressional hearings and reports, etc.--devoted to Latin America <http://www.gpoaccess.gov/cgp/index.html>

Supplementing the Monthly Catalog for earlier periods is the Catalog of the Public Documents of Congress and of all Departments of the Government of the United States for the period March 4. 1894-December 31. 1940, and the Checklist of United States Public Documents. 1789-1909. The latter source contains no subject, author, or title index.

The Congressional Record, published daily since 1873, can be a useful source. It is indexed by subject, and thus permits students to look up debates, hearings, committee reports, etc., having to do with Latin America. Many of these documents are now available through the Internet, at <http://www.gpoaccess.gov/>

An electronic index to the Congressional Record is available at <http://www.gpoaccess.gov/cri/index.html>

We were able to locate only a couple of collections in the Government Publications section having to do exclusively with the region.

(1) Bulletins of the Bureau of American Republics (ARI.3:60/895, etc.) were published in the 1890s and early 1900s by the U.S. Department of State, and are a compilation of information on economic and business conditions in various Latin American countries. They include statistical data, commercial directories, information on tariffs and laws governing foreign trade, and so on. Some of the volumes which can not be found in the shelves are available in the form of Microcards.

(2) U.S. Consular Reports (S4) covers the period 1896-1908.

This is accompanied by a series of Special Consular Reports (S4.9 V1 Pt. I), consisting primarily of information on economic and business conditions. Again, the volumes which are not found in the shelves are available as Microcards.

(3) U.S. Foreign Broadcast Information Service Daily Report: Latin America. This source is found not in the Government Documents section but in the periodicals section on the fourth floor, shelved alphabetically. Beginning publication in 1947, the Daily Reports summarize coverage of current events in foreign print and broadcast media. Hillman's collection of the Latin America report begins in 1973.

GENERAL COLLECTION

While the Microforms section probably contains the greatest volume of primary material on Latin America, the general collection is also a rich source of documentation, and probably contains a greater variety of sources. The sheer number of titles involved precludes our listing them all. Instead, we will refer briefly to some of the larger multi-volume collections, and then indicate procedures for searching out additional titles.

Multi-volume collections

Multi-volume collections of primary documents tend to fall into several categories. One is that of the documentary series based on the holdings of a national archive. Hillman contains several examples of this kind of source, based on the holdings of the national archives of Argentina, Brazil, Colombia, Mexico, Venezuela, and the Spanish imperial archives at Seville. (For specific titles and call numbers of these and other publications discussed in this section, see Appendix 1.)

A second type of documentary series is the published papers, correspondence, and personal archives of important public figures. Hillman holds numerous examples of this genre, including the papers of: Jose Artigas, Ramon Castilla, Benito Juarez, Francisco de Miranda, Bartolome Mitre, Bernardo O'Higgins, Juan Facundo Quiroga, Antonio Jose de Sucre, Francisco de Paula Santander, Jose de San Martin, and others.

A third type of series is the published records of government agencies. At the national level, these often focus on international relations, and are published with the purpose of

bolstering a nation's bargaining position in international disputes. A rather different type of official record, and one quite useful to social historians, is the proceedings (actas) of local municipal governments. These have been published for the colonial period for numerous Latin American cities; in the Hillman collection they are particularly abundant for Argentina, and are available for Caracas, Lima, La Paz, Quayaquil, and other cities as well.

A fourth type of documentary series, overlapping at times with the previous three, is the series focused on a given historical topic or event. Sometimes these are prepared by official agencies, national archives, or national academies; just as often they are prepared by individual historians drawing documents from a variety of sources. Among the larger such series on hand at Hillman are documentary collections on the Mexican Revolution (28 volumes), the independence struggles in Peru (40 volumes), and conditions of labor in colonial Mexico (8 volumes). (Note also the collections of this sort found in the Microforms section of the library.)

One- or two-volume publications organized around a central theme are so abundant that it would be hopeless to attempt to list them all. Instead we will now suggest ways for students to search for such sources on their own, in accord with their own particular research interests.

FINDING ADDITIONAL PRIMARY SOURCES

Hillman's on-line catalogue, PittCat, can be used quite efficiently to locate additional primary materials. One way to begin is with a subject search, using the name of the country in which one is interested. For example, typing in "S=Brazil--History" will produce over a hundred subject headings (e.g., "Brazil--History--1549-1810," or "Brazil--History--Revolution of 1930"), a number of which will contain the keyword "Sources." Under this heading one will find library holdings of primary sources. The items located in this initial search, however, by no means exhaust all the relevant items available. One needs to take several additional steps to verify the existence of further material. First, the PittCatt catalogue was inaugurated in 1986, and at that time included only works published since 1981. Pre-1981 items are gradually being added, but a small portion of the collection has not yet been entered, and thus can be located only through a card catalogue located next to the reference Desk.

Second, cataloguing is not always an exact science, and documents which are in fact primary sources do not always end up listed under the "Sources" heading. When students proceed to the stacks to locate the items which they have found in the catalogues, they should take some additional time to look at neighboring volumes with similar call numbers to see whether they too might qualify as primary material.

Third, while searching by country name is a good way to begin a subject search, students should be aware that primary materials may also be listed under subject headings other than the name of the country. For example, while material on the history of Colombian organized labor might appear under the subject heading of "Colombia," it is just as likely to appear under other subject headings, in which Colombia appears as a subheading: e.g., "Labor and Laboring Classes--Colombia," "Trade-Unions--Colombia," or "Syndicates--Colombia." Users are encouraged to consult the [*Library of Congress Subject Headings \(LCSH\)*](#) list, located at the Reference Desk, as part of an effective search strategy. In addition to presenting a controlled list of subject headings in alphabetic order, *LCSH* shows the relationships among those headings and provides other valuable information, such as scope notes that clarify usage and Library of Congress classification numbers that are associated with a particular subject heading. One should also search for the names of prominent individuals who took part in, or wrote about, the events or time-period in question.)

Finally, while "Sources" is the most frequently used subheading for primary material, students should be alert to other keywords as well. Indeed, searching by keyword opens even wider possibilities for identifying documentary sources. For example, a search under "k=argentina and microform" will reveal all the microform material related to Argentina. An alternative approach when searching PittCat is to "set search limits" by material type such as microforms. Other "search limits" include publication date, language, country of publication, location.

A second possibility of using the keyword search is through the use of specific Spanish or Portuguese words that frequently appear in primary sources: diario, periodico, revista, gaceta, boletin, correspondencia, archivo, cartas, informe, proclama, reporte, memoria(s), actas, bases, relacion(es), epistolario, documento, anuario, anales, compilacion, recompilacion, fuentes, capitular, notas, anotaciones, transcripcion, coleccion, papeles, libros, obras, ley(es), codigo, estatuto, decreto, medida, plan, plataforma, programa, estudio,

fundamento, tratado, pleito, arbitraje, censo, encuesta, mensaje, discurso, cuestion, convencion, asamblea, audiencia, cabildo, virreynato, corregimiento, municipalidad, intendente, etc. These words may be used in different combinations, with countries (k=peru and archivo), persons (k=bolivar and cartas), or events (k=memorias and revolucion and mexico.)

In short, bibliographic searching through the on-line catalogue is not a simple, one-step procedure. Like any historical research, it requires alertness, perseverance, creativity, and imagination.

APPENDIX 2

Internet Resources for Historical Research on Latin America

In recent years, the Internet has become a powerful means of communication and information. This section is intended as an introduction to some of the opportunities offered by this new tool for historians interested in research on Latin America. The most basic function of the Internet for historical research is as a reference guide. As already indicated the University of Pittsburgh subscribes to a number of fee-based Internet databases, to which any student or faculty member with a university computer account has free access. These may be accessed through the Hillman Library home page (<http://www.library.pitt.edu>).

A second reference source is the on-line catalogues of other libraries. Some of the major university libraries in the United States can be accessed through Hillman's home page <http://www.library.pitt.edu/books/catalogs.html>. Those of particular interest to Latin Americanists include the University of Texas-Austin, UC-Berkeley, and the University of Florida. A number of Latin American university library catalogues are also available on-line, and several national libraries as well. Many of these library catalogues can be located under other catalogs: <http://www.library.pitt.edu/books/catalogs.html> the library's web page at: <http://www.library.pitt.edu/>. Latin American libraries, and numerous other Latin America-related resources, are most readily located through the Latin American Network Information Center (LANIC) at the University of Texas <http://lanic.utexas.edu> accessible also through Pitt's Latin American Collection's web page under Guide to Latin American Studies:

http://www.library.pitt.edu/subject_guides/latinamerican/ This web page has an enormous amount of information and links conveniently organized by countries and subjects, providing access to Latin American databases, newspapers, library catalogues, private and governmental institutions, and international agencies. Another web page with an enormous list

Besides those general web pages, there are other reference links relevant for historical research. The Handbook of Latin American Studies (see above) can be accessed at <http://lcweb2.loc.gov/hlas/mdbquery.html> and can be searched by author, title, volume, or keyword. Finally, those interested in Latin American history should consult web-pages devoted to the general field of history, such as the Virtual Library on History, at the University of Kansas <http://history.cc.ukans.edu/history/index.html> and the Association for History and Computing <http://odur.let.rug.nl/ahc/histlink/history.html>

At this point the Internet's primary use for Latin Americanist researchers is as a reference guide. However, there are already some data bases available on the Net that contain primary sources, and these will doubtless become more numerous in the future. Some currently available examples include Mexican and Argentine Presidential Messages and Castro Speeches, both available through the LANIC home page; Political Data Base of the Americas <http://www.georgetown.edu/pdba/> which includes national constitutions of every American country; and the Historical Text Archive which has links to secondary and primary sources on Latin America, especially for Mexico. Another kind of primary source is full-text versions of books which have been put on-line. For example, Jose Carlos Mariategui's Siete ensayos sobre la realidad peruana is available at <http://www.mas.org.ar/formacion/mariategui/7%20ensayos.htm> Album on the Mexican American War <http://dragon.dgsca.unam.mx/coordhum/septiembre/album.html> created by the Universidad Nacional Autonoma de Mexico (UNAM), contains pictures and documents related to the war. And the Latin American Studies Association posts papers presented at its recent (since 1995) International Congresses <http://lasa.international.pitt.edu/>

Researchers interested in the more contemporary period will find ample material on the Web. Through LANIC and other general reference links, it is possible to access an enormous amount of information on regional and national politics, society, and economics. National

governmental agencies--such as Ministries of Economy and Bureaus of National Statistics-- and international and regional agencies--such as the United Nations Economic Commission for Latin America <http://www.eclac.cl> the Organization of American States <http://www.oas.org/> the Inter-American Development Bank <http://www.iadb.org/> and the Pan American Health Organization <http://www.paho.org/> are constantly publishing statistics and reports on the Internet, as are regional academic organization such as CLACSO <http://www.lanic.utexas.edu/project/clacso/>

Non-governmental organizations (NGO's) also contribute to this effort. For example, the Center for World Indigenous Studies has a Fourth World Documentation Project <http://www.cwis.org/fwdp/index.htm> with information about indigenous people of Mexico, Central, and South America. On-line newspapers and radio stations from every Latin American country also provide valuable information. LANIC offers a country-by-country list of newspapers and radios available on the Internet, such as:

The three papers just mentioned all have electronically searchable archives that greatly facilitate research on specific subjects. A number of Latin American radio stations also maintain sites on the Web. With the required software--RealAudio, TrueSpeech, etc., which are available free on the Web--listeners can tune in to these stations through their computers. Last but not least, there are two other sources of primary data available on the Web: maps and museums. The University of Georgia maintains a collection of colonial-period maps of the New World <http://www.libs.uga.edu/darchive/hargrett/maps/newworld.html>

LANIC also offers access to historical and present-day maps of the region. Museums and personal web pages offer pictures, portraits, art, music, etc., that may serve either as primary sources or to complement an investigation. To conclude, the Internet is a new and rapidly expanding source of information for Latin American historical research. It is not likely to replace archives or libraries, but does offer the possibility of supplementing both.
