### TRAINING HEALTHCARE PRACTITIONERS IN NIGERIA TO INCREASE ACCESS TO INCREASE CANCER AWARENESS, PREVENTION AND EARLY DIAGNOSIS

With rising rates of cancer in Nigeria, it is imperative that the public health community identifies ways to effectively increase access to cancer awareness, prevention, and early diagnosis. In a low-resource setting, digital technologies can play a crucial role in training healthcare professionals to increase screenings and referrals, and to enhance their knowledge of cancer control. eLearning can be used for training healthcare practitioners in Nigeria; further research into the feasibility, challenges and opportunities presented by eLearning platforms in the healthcare sector will be crucial going forward.

### **GENDER EQUITY PROGRAMMING—WHAT WORKS—EXAMPLES FROM THE AFRICAN CONTINENT**

Despite legislation to make marriage under age 18 illegal and policies governing divorce and inheritance protection, girls and women in Malawi still experience discriminatory customary practices and poverty that perpetuate child marriage. Ending child marriage will help Malawi achieve gender equality, women empowerment and reach goal #5 of the sustainable development goals. Using the activism of Chief Kachindamoto to annul child marriages, promote girl education and women's economic empowerment as a case study, this workshop applies an anthropological lens to analyze the tension between legal frameworks for gender equality, social norms and economic insecurity to arrive at multi-sectoral approaches to address the complex drivers of child marriages.
