# "I, a Toucan from the Headwaters: Amazonian Quichua Relationships to

**Nature**" a lecture by **Tod Swanson** (Associate Professor of Religious Studies, Arizona State University)

Tod Swanson is a specialist in Amazonian Quichua language and culture. His current research focuses on indigenous religious approaches to nature. His most recent article on this topic is "Singing to Estranged Lovers: Runa Relations to Plants in the Ecuadorian Amazon," *Journal for the Study of Religion, Nature, and Culture* 3:1 (2009) 36-65. Dr. Swanson currently manages a 600 hectare Amazonian forest preserve and botanical garden. He and his wife Josefina are active members of Comunidad Santu Urcu, a Napo Quichua community in eastern Ecuador, where they maintain a family home.

# "Economic Hit Man Details His Experiences Exploiting Latin America & the Middle East", a public talk by John Perkins (NY Times Bestselling Author of *Confessions of an Economic Hit Man*)

Corporate greed, corruption, and irresponsible policies were the forces that guided the work John Perkins did as an "Economic Hit Man" in the developing world. Perkins visits Pittsburgh for the first time to discuss how he went from the Peace Corps to brokering deals that left the developing world's rich richer, while the poor were further marginalized.

His work across Latin America and the Middle East will provide great insight to students on the very issues that continue to plague our geopolitical climate. Today, Perkins donates all proceeds from his speaking engagements to his nonprofit work which includes environmental sustainability efforts and human rights initiatives in the Amazon rainforest region. Some key topics Perkins will cover include corporate responsibility, ethics in both the public and private sector, and sustainable environmental practices.

As Chief Economist at a major international consulting firm, Perkins advised the World Bank, United Nations, IMF, U.S. Treasury Department, Fortune 500 corporations, and countries in Africa, Asia, Latin America, and the Middle East. During the 1980s, he was CEO of an alternative energy company that was a pioneer in developing environmentally beneficial power plants. He worked directly with heads of state and CEOs of major companies to promote and develop the types of projects described in *Confessions of an Economic Hit Man*, a book that spent more than sixty-five weeks on the New York Times bestseller list.

Following his lecture, he will take questions from the audience and sign books for attendees. All three books detailing his work will be available for purchase, including *Confessions of an Economic Hit Man, The Secret History of the American Empire*, and his newest book released last year *Hoodwinked*.

**"Racial Silence and Urban Policy in 20<sup>th</sup> Century Brazil"** a Brown Bag Work-in-Progress Workshop with **Brodwyn Fischer** (Associate Professor, History Department, Northwestern University) and co-discussant **Lara Putnam** (Associate Professor, History Department, University of Pittsburgh)

Dr. Fischer specializes in modern Brazil and Latin America, with an emphasis on histories of law, cities, migration and social inequality. Her book, *A Poverty of Rights: Citizenship and Inequality in Twentieth Century Rio de Janeiro* (Stanford, 2008), won the Social Science History Association's President's Book Award in 2007, the Conference on Latin American History's Warren Dean Prize for 2007-8, and the Urban History Association's Best Book Prize (non-North American) for 2007-8. Her dissertation received awards from Harvard University and the New England Council of Latin American Studies. Fischer has also published on issues of race, criminal justice, and urban inequality in the *Latin American Research Review* and in several essay collections in the United States and Brazil.

#### "Stitching Curtains, Grinding Plastic: The Transformation of Workers and

**Things in Buenos Aires**" a lecture by **Karen Ann Faulk** (Carnegie Mellon University) This talk looks at how prevailing notions of moral and material value in post-neoliberal Argentina are challenged by the recuperated businesses movement (*las recuperadas*) and organizations of street recyclers (*cartoneros*). Comprised of those who feel discarded by a system no longer capable of employing them, these groups use their labor to physically transform objects that have been similarly discarded. In the process of stitching old pieces of cloth into curtains, or grinding carefully separated plastic bottles, they argue that they are also transforming themselves, from surplus labor into workers. In doing so, they seek a discursive change over the meaning of work within a highly contested climate over the nature and direction of the country. Presenting ethnographic examples that illustrate the interrelation of people and things in ideas of personal, cultural, and national transformations, this talk draws attention to the materiality of discourse and to the struggles over meaning that are embodied in and expressed through these material conversions.

Dr. Faulk is an anthropologist specializing in political and legal anthropology, with a current focus on social activism in Argentina and Latin America, and teaches in the Department of History and Global Studies at Carnegie Mellon University.

This symposium has as its purpose to commemorate the centennial of the death of Julio Herrera y Reissig, and the centennial of the births of Miguel Hernández and José Lezama Lima. These three distinguished writers are honored collectively not only for their contributions to the genre of poetry, but also for their contributions to the essay, short story and novel. Julio Herrera y Reissig was a marginalized poet in the Uruguayan society of his time; Miguel Hernández died in a prison cell under Franco's regime; José Lezama Lima was not allowed to leave Cuba during Castro's revolutionary period. For each, writing was an act of resistance, a source of sustenance from which these writers drew strength to endure the circumstances that surrounded them.
