Upcoming CLAS Lecture Series & Other Lectures

"Volcanically Induced Loss of Archaeological Sites, Montserrat, West Indies" a lecture by **Dr. David R. Watters** (Curator of Anthropology, Carnegie Museum of Natural History and Adjunct Faculty, University of Pittsburgh)

Montserrat has sustained damage to its cultural heritage and natural environment for fifteen years, since volcanic activity began at the Soufriere Hills Volcano. Research performed prior to the onset of eruptions in 1995 had established spatial and temporal data for the island's prehistoric and historic archaeological sites, a very fortunate circumstance in view of the subsequent devastating volcanic activity. Pyroclastic flows and surges and periodic dome collapses have so deeply buried sites and so dramatically altered local topography as to render their future rediscovery arduous and their excavation virtually impossible. The extent of the impact of volcanic deposits is vividly depicted in photographs taken at ground level, aerial shots from plane and helicopter, and satellite images.

Dr. Watters received his B.A. from Wake Forest University (1969), M.A. from University of Nevada, Reno (1976), and Ph.D. from University of Pittsburgh (1980). He joined the staff of Carnegie Museum of Natural History in 1982.

"Brazilian Presidential Elections 2010" a presentation and discussion by **Mr. Paul Sotero** (Director, Brazil Institute at the Woodrow Wilson International Center) Mr. Sotero is a frequent lecturer on Brazilian affairs at U.S. universities and think tanks, and has appeared on national radio and television news programs. A native of São Paulo, he started his career in journalism at *Veja* weekly magazine in 1968 and held positions in Recife, Paris, Lisbon, São Paulo, and Brasília. In Washington, he worked also as correspondent for *Istoé* weekly magazine and the financial daily *Gazeta Mercantil.* He holds a MA in Journalism and Public Affairs, American University, Washington DC, and has been the recipient of the 1987 Maria Moors Cabot Award, from Columbia University Graduate School of Journalism, and the 1993 Distinguished Visiting Lecturer award from the Foreign Service Institute of the U.S. State Department. In Brazil, he was awarded the 1978 Prêmio Abril de Reportagem for a *Veja* cover story on Paraguay and for an investigative report on the assassination of Chilean general Carlos Prats.

The graduate students of the Department of Hispanic Studies at Texas A&M University, College Station, Texas, invite you to submit abstracts for the First Annual Texas A&M Department of Hispanic Studies Graduate Student Symposium. This symposium has as its purpose to commemorate the centennial of the death of Julio Herrera y Reissig, and the centennial of the births of Miguel Hernández and José Lezama Lima.
