Brief description of the courses:

• Foundations of Rehabilitation:

The content of this course reflects the origins of vocational rehabilitation and rehabilitation counseling through the philosophy, legislature, and clinical history of the discipline. The intent for studying the history and foundations of vocational rehabilitation is to gain a perspective on the nature and scope of practice today and in the future

Assistive Technology I and II

Theoretical and practical coursework explaining the interdisciplinary approach to the selection, implementation and provision of Assistive Technology Services to persons with disabilities to achieve their educational, vocational, transitional and independent functional goals of individuals with disabilities.

Individual and Social Experience of Disability

The content of this course reflects on the individual consequences of disabilities, also psycho-social aspects of disability.

• Medical Aspects of Disability:

This course will provide an in-depth review of the anatomical structures of the human musculoskeletal system. Clinical faculty combined their efforts with skilled dissection anatomists to present a clinically pertinent musculoskeletal anatomy course

• Vocational Rehabilitation:

The course gives the basic idea about the job legislation, required accommodation on the part of employers and role of Office of Vocational Rehabilitation in promoting employment for persons with disabilities. The course has very creative approach of inviting guest speakers every week from the private and public sector to talk about the possible opportunities to enter into the workforce for persons with disabilities. Various assignments and group discussion were also the part of the class which made the learning very thought-provoking and interesting.

Pittsburgh Employment Conference:

Attended the biennial Pittsburgh Employment Conference for Augmented Communicators – fondly known as PEC. This was held August 5 – 7, 2005 in Pittsburgh, PA with the theme being "Employment and Community Integration." More than 250 people attended PEC including more than 50 people who rely on AAC. Together, practitioners, parents, state vocational rehabilitation professionals, students, and researchers joined folks who use AAC to hear more than 28 platform presentations. Topics included: what VR counselors should know and how to interact effectively with them; strategies for becoming employed; effective community interaction; community interaction at the university, on the job, in public places, and in the hospital. More than half of the presentations were provided by individuals who use AAC.

Through the poster presentation I highlighed UPMC's wheeled mobility and seating devices for individuals with mobility impairments and home accessibility through the use of Telerehabilitation (TR) consultation model
