INTERNSHIP

From April to July in 2010, I did my 4 months internship with Plan International (USA) in Washington DC.. Plan International is one of the oldest and largest children's development organizations in the world. It works in 48 developing countries across Africa, Asia and the Americas to promote child rights and lift millions of children out of poverty. Plan works with more than 3,500,000 families and their communities each year. Plan is independent, with no religious, political or governmental affiliations. Plan international is a child centered, community based international. Plan has 16 National offices to do fund-raising to support the program in 48 countries. Plan USA is one these National offices. I supervised by the Director of Technical Support Unit of Plan USA. My responsibility was to provide technical support to various country offices of Plan to apply for Round 10 of Global Fund and World Bank. Before I finished my internship, one country office succeeded in

applying for PR (principle recipient) of their county R10 Global Fund. Two country offices were successful to be nominated as SPR (sub-principle recipient) of their county for R10 Global Fund.

Also, as a multi-national organization and has staff from different countries, working with Plan USA made me learn a lot how to work in a multi-cultural environment.

CONFERENCES AND PRESENTATIONS

1. Conferences I attended:

I attended quite a few wonderful conferences which broad my experience so much and helped me to build up a very useful network in USA. The conferences I attended were as follows.

- Core Group Meeting: this meeting was held at the end of April, 2010 in Baltimore, MA. Almost all of local NGOs, USAID and other international organizations participated in this meeting. In this conference, programs were being done around the world and what experience and lessons were presented. It was a very good opportunity for me to know the programs related with public health on going around the world, as well as how to improve our programs in China. Also, I built a broad net work in this meeting which would be so helpful to my career and the programs I will do in China.
- Women Deliver 2010: this meeting was held on 7-9 June in Washington DC. The meeting put world leaders on notice that the time for action on maternal health is now, 3,400 advocates, policymakers, development leaders, health care professionals, youth, advocates, and media from 146 countries converged on Washington DC at Women Deliver 2010. More than 800 speeches and presentations were given at the six plenary and 120 breakout sessions, and the heads of five UN agencies, plus the Secretary-General, were represented. Thirty countries, UN agencies, the World Bank, corporations, and foundations helped support Women Deliver. Through this meeting I got to know what is going on

- around the world about women deliver and I really broad my perspective.
- Global Health council 2010 Conference: This conference was held for 5 days in Washington DC. More than 2,000 attendees represented the diverse array of global health professionals, which presented not only practical experience, but also research tracks around the world. Through this conference, I got to know the most impressing problems in terms of global health and what programs and efforts various countries and organizations were putting on global health.
- Zambia conference: This conference was held in September 2009 at Pittsburgh
 University. Professionals from Zambia introduced some health programs in their
 country. I built up a very good relationship with the experts from Zambia.

 Department of Family Medicine, School of Medicine University of Pittsburgh.
 Meanwhile, I got to know three more staff of this department. They are, Dr.
 Chyongchiou Jeng Lin, and Dr. Howard B Degenholtz, and Dr. Zhang. Getting to know them made it possible for me to attend lectures they held periodically which was very meaningful to my work.
- I got to know Dr. Carolyn Ban and Dr. Kevin P Kearns at GSPIA. Both of them were with high reputation about classes they giving and their practical experience in the field of the management of Public and Non-profit organizations.
